

MR. SOAKER HOSE TERMS & CONDITIONS FOR DROP SHIP

CRITERIA: YOU MUST OWN A RETAIL STORE, INTERNET STORE, NURSERY OR RETAIL ESTABLISHMENT OF SOME TYPE. NO SALES TO INDIVIDUALS. A BUSINESS LICENSE, FEDERAL ID NUMBER, SALES TAX CERTIFICATE ARE REQUIRED.

TERMS: CREDIT CARD (VISA/MC/DISCOVER)

MINIMUM ORDER: \$10.00

BACK ORDERS: OUT OF STOCK ITEMS WILL NOT BE SHIPPED OR CHARGED AND WILL NEED TO BE RE-ORDERED.

FREIGHT: ALL ORDERS ARE SHIPPED UPS GROUND, UNLESS OTHERWISE NOTED FROM PHOENIX, ARIZONA. PLEASE NOTIFY US FOR LARGE ORDERS SO WE CAN QUOTE YOU FREIGHT VIA COMMON CARRIER.

DROP SHIP FEES & CHARGES: ALL PRICES ARE POSTED ON THE WEBSITE. CART WILL GIVE UPS SHIPPING CHARGES . TOTAL IN THE CART IS THE TOTAL YOU PAY.

SHIPPING: LEAD TIME IS NORMALLY 24-48 HOURS. (WE WILL NOTIFY IF DELAY OF PROCESSING OCCURS) THE FACTORY RESERVES THE RIGHT TO SHIP VIA THE LEAST EXPENSIVE ROUTE AND CARRIER. WHEN YOUR ORDER IS SHIPPED TO YOUR CUSTOMER YOU ARE PROVIDED WITH A UPS TRACKING NUMBER. ALL ORDERS ARE SHIPPED WITHIN THE US. ALL OTHERS WILL REQUIRE A FREIGHT QUOTE.

PACKING LIST: YOU MAY EMAIL OVER YOUR PACKING LIST TO BE PLACED WITH THE ORDER, WHEN PLACING YOUR ORDER. IF NO PACKING SLIP IS PROVIDED, A GENERIC ONE WILL BE PLACED IN THE PACKAGE.

PLACING YOUR ORDER: FOR RECURRING ORDERS YOU CAN CREATE AN ADDITIONAL SHIP TO ADDRESS IN THE SHOPPING CART.

SHIPMENT SHORTAGES: FACTORY MUST BE NOTIFIED OF ANY SHORTAGES WITHIN 5 BUSINESS DAYS OF RECEIPT OF GOODS. NO CREDIT WILL BE GIVEN UNTIL FINAL DEPOSITION IS DETERMINED.

PRICING: PRICES SUBJECT TO CHANGE WITHOUT PRIOR NOTICE. ALL CURRENT PRICING IS ONLINE.

DESIGN: WE RESERVE THE RIGHT TO REDESIGN, ALTER OR MODIFY OUR PRODUCTS WITHOUT INCURRING LIABILITY FOR ANYONE'S INVENTORY OR FUTURE REPAIR PROBLEMS.
